At one time, the use of corporal punishment by parents in child-rearing was considered normal, but in the second half of the nineteenth century this began to change, in Quebec as well as the rest of the Western world. It was during this period that the extent of ill-treatment inflicted on children—treatment once excused as good child-rearing practice—was discovered. This book analyzes both the advice provided to parents and the different forms of child abuse within families. Cliche derives her information from family magazines, reports and advice columns in newspapers, people's life stories, the records of the Montreal Juvenile Court, and even comic strips. Two dates are given particular focus: 1920, with the trial of the parents of Aurore Gagnon, which sensitized the public to the phenomenon of "child martyrs;" and 1940, with the advent of the New Education movement, which was based on psychology rather than strict discipline and religious doctrine. There has always been child abuse. What has changed is society's sensitivity to it. That is why defenders of children's rights call for the repeal of Section 43 of the Canadian Criminal Code, which authorizes "reasonable" corporal punishment. *Abuse or Punishment?* considers not only the history of violence towards children in Quebec but the history of public perception of this violence and what it means for the rest of Canada.

Powerful and moving, *Heroes of Their Own Lives* offers an honest understanding of a persistent problem and a realistic view of the difficulties in stopping it.

Single Mothers and Their Children - Shurlee Swain 1995-12-11

This 1996 book is a comprehensive history of single motherhood in Australia. Shurlee Swain

and Renate Howe tell the powerful, if painful and often moving, story of these women and their children and the lives they constructed. Starting in the 1850s when abandonment and infanticide were not uncommon, the book's main focus ends in 1975 when the legal status of illegitimacy was abolished. The book covers issues of baby farming, infanticide, abortion, sex education, birth control, adoption and marriage, in effect becoming a history of sexual practice in Australia. While tracing profound changes from a time when single mothers were locked in gaol for discarding their babies to the establishment of state benefits, the authors find a good deal of continuity over the period. This book makes an important contribution to social, welfare and women's history in Australia.

We Have Raised All of You - Katy Simpson Smith

White, black, and Native American women in the early South often viewed motherhood as a composite of roles, ranging from teacher and nurse to farmer and politician. Within a multicultural landscape, mothers drew advice and consolation from female networks, broader intellectual currents, and an understanding of their own multifaceted identities to devise their own standards for child rearing. In this way, by constructing, interpreting, and defending their roles as parents, women in the South maintained a certain degree of control over their own and their children's lives. Focusing on Virginia and the Carolinas from 1750 to 1835, Katy Simpson Smith's study examines these maternal practices to reveal the ways in which diverse groups of women struggled to create empowered identities in the early South. *We Have Raised All of You* contributes to a wide variety of historical conversations by affirming the necessity of multicultural -- not simply biracial -- studies of the American South. Its equally weighted analysis of white, black, and Native American women sets it distinctly apart from other work. Smith shows that while women from different backgrounds shared similar experiences within the trajectory of motherhood, no universal model holds up under scrutiny. Most importantly, this book suggests that parenthood provided women with some power within their often-circumscribed lives. Alternately restricted, oppressed, belittled, and enslaved, women

sought to embrace an identity that would give them some sense of self-respect and self-worth. The rich and varied roles that mothers inherited, Smith shows, afforded women this empowering identity.

Since many coping mechanisms used by an abused child actually become dysfunctional behaviors in an adult, this knowledge helps me to be more effective in identifying problem behavior and its source, so we can then explore ways to transform dysfunctional coping into healthy adult behaviors. Before even becoming an adult, Vanessa Steel recognized that her abuse survival strategies had revealed a unique gift. She then managed to transform these coping tactics into resourceful and valuable skills by which she was able not only to help herself, but to actually help others. EXCERPT FROM THE BOOK When Vanessa found her abusive mother collapsed on the floor, near death, she knew she didn't have much time left to address her suppressed memories of her traumatic childhood. She began to articulate in writing the important questions about why her mother had abused her so cruelly from the moment of birth. The book then chronicles Vanessa's story of abuse and torture at the hands of her mother. Although there is evidence that the abuse began very early - at 18 months, Vanessa supposedly rolled off the bed and broke her leg - Vanessa's conscious recollections begin at about age two. Her mother was the main perpetrator, but at the age of six, Vanessa's maternal grandfather began to abuse her sexually. The abuse was condoned and aided by her maternal grandmother, and her father remained largely in denial. Vanessa never understood why she was being abused, although when she turned eight she found out she was adopted. The abuse took diverse and extreme forms: scaldings, beatings, starvation, being regularly left outside in the cold, tied up and left to sleep in the pigsty - all subject to her mother's unpredictable fits of rage. The abuse was not just physical; Vanessa's mother called Vanessa the devil's child and explained the punishments as God's revenge. Vanessa's brother, Nigel, also experienced abuse at his mother's hands, although to a lesser degree. When he began to experience seizures and was eventually diagnosed with epilepsy, Vanessa's mother blamed her for turning her brother into a devil's child, and held her responsible for

accidents that happened. When Vanessa attempted to tell others about the abuse, they either didn't believe her or accepted her mother's "vivid imagination" explanation. This vulnerable child had no one to protect her, no means of escape, and often lost all hope. Buy a copy to keep reading!

Child C - Christopher Spry 2008-08-04

In April 2007, 62-year-old Eunice Spry was sentenced to 14 years in prison for the systematic wounding, cruelty and assault of the vulnerable children whose welfare had been entrusted to her. Her Gloucestershire home should have been a refuge. Instead it became a prison where, over the course of 20 years, her charges were routinely abused and tortured. To the outside world, Jehovah's Witness Spry presented herself as a pillar of the community. Behind closed doors she was a sadistic tyrant who beat the children with metal bars, forced wooden sticks down their throats and made them eat lard, bleach, vomit and faeces. The details of the trial horrified the nation, and attracted considerable press attention. Now, for the first time, one of the victims - known in the case as 'Child C' and now 19 years old - tells the full, shocking story of what went on in Eunice Spry's house of evil. Child C is a gripping, heartbreaking story of enforced isolation, psychological and physical abuse and a childhood denied. Despite all he has been through, Christopher Spry is a survivor with a zest for life. With his former foster mother in prison, he can finally tell the story of his suffering and what it is like to grow up brutalised and abandoned with no one to hear your plight.
